The Inspection Report is non-invasive and constitutes an opinion of the Present Condition of the property based on a visual inspection of the readily accessible and visible major systems and components of the Primary Residence on the Property.

The inspection and Inspection Report **do not** constitute a guarantee, warranty or an insurance policy.

The Client is encouraged to participate in the visual inspection process and accepts responsibility for the consequences of electing not to do so.

The condition of certain systems, components and equipment will be randomly sampled by the Inspector. Examples include window/door operation, electrical receptacles, switches and lights, cabinet, mortar, masonry, paint and caulking integrity and roof covering materials.

Weather conditions may limit the extent of the inspection process; the Client understands the scope and accuracy of the Inspection Report can be effected weather conditions existing at the time of inspection.
